RESEARCH CONDUCTED:

The research on *The Line Up* included identifying, acquiring, viewing and/or listening to a large variety of Primary Sources (scripts and network documents, broadcasts, and interviews) and many Secondary Sources.

At the start of my research, I constructed a database into which I would input episode titles, broadcast dates and times, cast, crew, and other episodic information. This database also included fields for my observations and additional information from all the sources I consulted throughout the research process. Having the information in a database allows me to easily generate queries and reports on various aspects of the series, such as the number of times that a specific member of the cast or crew worked on the series and in which episodes.

When I am researching an Old-Time Radio series, I acquire and listen to all the episodes of the series that are currently available. Acquisition of shows is an on-going process; I have acquired several additional shows that were not available when I started researching *The Line Up*. For this series I also listened to interviews of one of the series' primary writers, E. Jack Neuman and other

people who participated in the series.

Next, I reviewed many Secondary Sources such as newspaper daily radio programming listings and notes, trade magazine articles, and books on Old-Time Radio. The book, *Radio Series Scripts*, 1930–2001: A Catalog of the American Radio Archives Collection, complied by Berard and Englund provided an initial (But Not Final) listing of episode broadcast dates and titles.

Accessing Primary Sources: An Expensive Proposition

Finally, I traveled from Colorado to a California archive where the printed Primary Sources (scripts, network contract and broadcast documents, and other materials) for *The Line Up* reside. Many archives only allow on-site access to their collections and usually do not allow photocopying of scripts and other documents. In order to obtain the most accurate and complete information, travel is a costly, but a necessary step in researching an entire series. It is a step taken by only a very few of the most dedicated OTR researchers and writers.

I spent five days in March, 2013 at the archive looking at all of the scripts and extensive CBS documentation in the KNX Collection for *The Line Up*. The scripts (which sometimes contained annotations) and additional network documents such as Property Purchase Records, provided much new information and in some cases, provided corrections to information, such as episode broadcast dates, that had been compiled from other sources. During this time, I also viewed the series scripts and associated documents in the E. Jack Neuman Collection.

In March, 2014 I spent two days at the archive looking at the scripts in the KNX Collection for *The Line Up* and writing short episode plot descriptions for episodes that are currently not known to be in circulation. These descriptions will help in the identification of broadcasts of any additional episodes that come into circulation.

Information Entry and Evaluation:

An on-going activity throughout the research process is information entry and evaluation. I input episode title and broadcast date, cast, crew, and other episodic information into the database.

Information evaluation is an important component of any research project. It is a winnowing process: separating the accurate information (the wheat) from the inaccurate information (the chaff).

Broadcast Log Updates:

This *The Line Up* broadcast log will be updated as additional information about the series, such as additional episodes coming into circulation, surfaces.

SERIES TITLES:

Titles abound for this series. CBS documentation during the concept development phase of series tentatively referred to the series as *Lineup For Murder* or *Police Lineup*. The Audition show was announced as *Police Lineup*. The series scripts and newspaper listings give the name of the series as *The Lineup, The Line-Up*, and

Most Frequently on the Script Covers and Dialog Pages, Network Contracts, and Broadcast Documents, *The Line Up*. This is the series title is used in this broadcast log.

OPENING AND CLOSING:

The announcer's opening dialog for the series was remarkably consistent during the run of the series:

"Ladies and Gentleman, we will take you now behind the scenes of a police headquarters in a great American City, where, under the cold, glaring lights, will pass before us the innocent, the vagrant, the thief, the murderer. This is THE LINE UP!"

For the first few episodes the last sentence of the announcer's opening dialog was, "We take you now to THE LINE UP!"

The closing dramatic portion of each episode usually consisted of Sergeants Greb and later, Karger starting another Line Up. This dialog signified that the battle against crime never ends.

SERIES BACKGROUND & DESCRIPTION:

The Line Up was a police procedural series dealing with the daily aspects of law enforcement. Listeners got a good feel for the period police work conducted without being overwhelmed with procedural details. For the most part, the cases were not high-profile; they were the usual fare for a big-city police force: assaults, robberies and muggings, burglaries, con games, and murders. Unlike most series of this genre, there was very little narration.

The Line Up focused on the activities of two police detectives: a Lieutenant and a Sergeant. Both men were dedicated, very capable, long-time veterans of the police force. These men were not only partners, but also good friends. While the Sergeant was the more emotional of the pair; he was not a sidekick, comic relief caricature. The Lieutenant was slow to anger, but in the few episodes where was temper is revealed, he did not allow it to cloud his judgement.

The audience got to observe the both the business and human sides of the detectives working out of the 16th Precinct. Over the course of the series, we learned professional and personal facts about the two lead characters. The Lieutenant was a bachelor and that the Sergeant was married. The leads often discussed the non-work aspects of everyday life not only between themselves, but also with their co-workers. In one episode there was a discussion about setting up a bowling league; in another, a conversation about what to buy a colleague for his birthday.

For a series to be successful, it had to be different than others in its genre. There were several plot devices incorporated into this series that made for quite enjoyable listening and that set *The Line Up* apart from others of its ilk.

Locale: A Great American City

The Line Up did not use a named city as the backdrop for the series, it was

simply referred to as a great American City. Criminals came there from most U. S. major cities to attempt to ply their nefarious trades. The Great American City was definitely a composite of several cities: it had a large suburban area, a port, and at least one ferry. There were hot Summers and cold, snowy Winters.

One of *The Line Up*'s primary writers, E. Jack Neuman, grew up in Denver, Colorado. His scripts are filled with references to streets and places in the Denver area. It can be assumed that other writers for the series similarly included their familiarity of other cities in their scripts.

A Line Up - The Usual and Unusual Suspects

The opening action of each episode focused on a line up. Suspects were brought in for witnesses to identify. They were a wide-range of society as the opening stated, ". . . the innocent, the vagrant, the thief, the murderer. . ." If a suspect was identified, he or she was held for questioning. Most were obviously hardened criminals. Some of the suspects were quite eccentric characters. Howard McNear often appeared as one of the suspects or as a witness.

Frequently Lt. Guthrie would be called away from the opening line up to investigate a completely different case that would become the center of that episode.

Casts/Roles and "Doubling"

The episodes of *The Line Up* were heavily populated with characters. Most episodes had at least 11 characters; a few episodes had as many as 19. The number of actors appearing in single episode varied with most episodes employing the talents of between 8 and 10 actors.

Lieutenant Guthrie and Sergeant Greb were the only two recurring characters on *The Line Up* when the series started. Regular, supporting characters were not added until the series had been on the air for several months. These supporting characters on the series included: Sergeants Tom Quine and Dave Asher, and Captain Bill Waldo. Quine and Asher frequently worked on cases with the two lead characters.

Appearing in the opening line up scene were the two leads, at least one and often two supporting cast, and four to six guest cast members. The supporting and several guest cast members often "doubled" or played two characters in a production.

Trivia: Was that Raymond Burr or Ray Hartman?

Raymond Burr appeared in at least 21 episodes of the series, but was only mentioned in the closing credits of 10. How was this possible? From March, 1951 through June, 1952 Burr used the name of Ray Hartman approximately 30 times when appearing on radio, mostly on *Dangerous Assignment, The Line Up* and *Yours Truly, Johnny Dollar*. This fact was verified by perusing the scripts for both series.

A VERY, VERY BRIEF RETURN TO THE RADIO AIRWAVES

The following is a segment of the article "THE LINE UP Anatomy Of A Police

Procedural," by Stewart Wright which appeared in the newsletter of the Society to Preserve and Encourage Radio Drama, Variety, and Comedy, *The Radiogram*, January, 2014. By permission of the author.

The Line Up Reprise of September 22, 1953

... The Line Up made a very brief reprise several months after it went off the air during the September 22, 1953, broadcast of *Yours Truly, Johnny Dollar* titled "The William Post Matter."

This recently found episode has many connections with *The Line Up*. This episode opens with Johnny Dollar being contacted by Ray Kemper, a representative of an insurance company, who wants Johnny to investigate the murder of a policy holder in New York City. Ray Kemper was a CBS sound effects artist who frequently appeared on both series including this *Johnny Dollar* episode. Johnny goes to the Big Apple to start his enquiry and meets with the detective heading up the NYPD investigation, Lt. Roseman, played by Bill Johnstone.

At about the 20-minute mark, Lt. Roseman and Sgt. Hanley (played by Jack Moyles who had played Sgt. Pete Karger on *The Line Up*) conduct a "line up" in which frequent *Line Up* guest actor Howard McNear appears as a murder suspect. In fact, all of the actors appearing in this *Johnny Dollar* episode with the exception of John Lund also appeared on *The Line Up*. The "line up" segment lasts about one minute and it is immediately followed by a few notes of *The Line Up* theme that are used as a musical bridge—performed by Eddie Dunstedter who conducted and played music on both series. Moreover, the episode was written by Blake Edwards and directed by Jaime Del Valle. . . .

THE JUMP TO THE SMALL SCREEN

As early as mid-May, 1951 CBS considered producing a television version of *The Line Up*. The radio leading actors: Bill Johnstone and Wally Maher were tested to reprise their characters on the small screen. Blake Edwards was tasked with writing the series pilot script. It is not known if a pilot episode was made in 1951.

On October 1, 1954 the series ultimately premiered on television as *The Lineup*. It ran on network television for six seasons. Different lead actors were chosen for the television series. The locale for the small screen version was a specific city: San Francisco, CA. It was later syndicated for many years as *San Francisco Beat*. At least two dozen actors from the radio version including Jack Moyles also appeared on the television version of the series.

AND ON TO THE BIG SCREEN

In 1958 a feature film version of the series was released. Jack Moyles appeared in a small, uncredited role.

SPONSORS:

Mainly Sustaining. Wrigley's Gum (15 episodes), the U. S. Army and Air Force Recruiting Service (5 episodes), and Plymouth (2 episodes). See the episode listings in the **LOG** for specifics.

RE-USE OF SCRIPTS:

Five scripts were reused on the series; one of these scripts was reused twice. The reused scripts normally retained their titles (The reused scripts are identified in the **LOG**.) These reuses were New Productions of Previously Used Scripts and were NOT Rebroadcasts of Previously Recorded Electronic Transcriptions.

Also, at least one E. Jack Neuman script from *The Line Up*, "The Fur Flaunting Floozie," was later rewritten by Neuman for use on *Yours Truly*, *Johnny Dollar*, the first time as the 1953 30-minute "The Rochester Theft Matter" and later as part of the 1956 multi-episode "The Todd Matter." For the 1956 effort Neuman used a nom de plume, John Dawson.

LOG:

Episode Titles:

All Episode Titles used in this Broadcast Log were taken from the Scripts and other CBS Documents. Episode Titles for *The Line Up* were not announced during the episode opening or at other times during the broadcast. The scripts for the first 12 broadcasts of *The Line Up* were untitled. For much of its run, the script titles were often of the alliterative, tongue twister variety and liberties were often taken with the spellings, such as "Babs the Baggy Bungling Brunette Bombshell," "The Careening Cadillac's Crushed Cadaver Case," "Wacky Williams' Wooftop Wrangle," Mirthless Moonshiner's Methyl Murders," and "Kastro's Kop Killing Karnage Kase." These seemingly ridiculous titles usually were directly related to the plot line of their respective episode. The primary announcer for the series, Dan Cubberly, was probably delighted that he didn't have to announce them.

Lack of Consecutive Episode Numbers:

As most of the scripts for this series were unnumbered, no consecutive episode numbers are included in this broadcast log.

At one time, some collectors mistakenly thought numbers on Armed Forces Radio transcription discs reflected CBS consecutive episode numbers for *The Line Up.* As a result, incorrect broadcast dates were assigned for some episodes based on these consecutive AFRS disc numbers.

Episodes in Circulation:

There are many Incorrectly dated and/or titled shows for *The Line Up*. As of February 19, 2015, more than 210 shows have been found and are actually 76 episodes out of the 118 from the CBS run of the series and the 1 audition show. Episodes that are currently known to be in circulation are highlighted. <u>Listening to and Assigning Correct Broadcast Dates and Titles:</u>

Copies of all shows that have been found have been listened to and assigned their Correct Broadcast Dates and Titles using episode-specific information contained in

the database compiled and maintained by the broadcast log author. This database includes extensive information from the series scripts, network and series documentation, and other sources listed in the **SOURCES**CONSULTED portion of this log. Common collector-assigned titles are listed following the actual titles in a Sans Serif Font.

Available But Not In Circulation:

Some sources list as many as ten additional episodes as being available, but no copies of these episodes are known to be in circulation. Based on what is known about these episodes, six may be valid. These episodes are not shown as in circulation in this Broadcast Log.

Partial Transcriptions, Not Rehearsals:

The shows in circulation for two episodes have only the dramatic portion (actors' dialog and sound effects) of the program. There is no music or announcer dialog. *The shows are Partial Transcriptions and Not Rehearsals*. The Dramatic Portions of these episodes were taped well in advance of their scheduled broadcasts. Flubbed lines were later removed. The music and announcer's dialog were added on the day of the broadcast. While Partial Transcription was a common radio production process in the late 1940's through the mid-1950's, relatively few of these dramatic Portion Partial Transcriptions survive.

Same Collector-Assigned Titles, But Completely Different Episodes:

Some episodes known to be in circulation have the same collector-assigned title, but are actually completely different episodes.

Broadcast Dates and Air Times:

Broadcast Dates and Air Times shown in this broadcast log are from a variety of sources including the series broadcasts, scripts, extensive Network, and other documentation. When ever possible, Broadcast Dates, and Air Times have been verified using Secondary Sources. All Broadcast Days and Air Times used in this Broadcast Log reflect broadcasts of the CBS flagship station, WCBS in New York City.

NOTE: It is known that some CBS affiliates were given the freedom to broadcast the series on different days and times. These affiliates used transcriptions they made from the CBS Network broadcasts. No special broadcasts were made by CBS for affiliates that chose to broadcast *The Line Up* at off times.

Broadcast Day and Time Changes:

The Line Up experienced many broadcast day and time changes during its CBS run. The series occupied 13 different broadcast day and/or time slots! The log is divided into sections with the day and time of broadcast listed at the beginning of each section.
